

**LICENSE AGREEMENT TO USE  
GEM Simplified GLOBAL SEISMIC HAZARD MAP**

Whereas

1. GEM Foundation created and owns the entire intellectual property rights on the work called “The Global Earthquake Model (GEM) Simplified Seismic Hazard Map, hereafter “the Work”.
2. The Work consists of a global data layer containing georeferenced hazard indicator values created in 2021 by the GEM Foundation.
3. The Work, at the time of the activation of this license agreement, is not intended for public distribution;

and

**(the licensee is the subject who acquires a copy of the Work)**

describes how the Work may be used. The Work is not intended for publication or dissemination. Beyond what is provided below, the Work should be treated as PRIVATE and CONFIDENTIAL.

**1 – Rights granted**

This license agreement grants the licensee a worldwide, non-exclusive, permission to use the Work internally (including for commercial purposes), at its own risk. The licensee is not permitted to publish or disseminate the Work without explicit, written permission from the GEM Foundation

**2 – Fee**

For the rights granted in the previous section, the licensee agrees to pay the licensor the amount of 2,500 (two thousand five hundred) UK Pounds Sterling in a single installment upon the date of activation of this license. This amount includes taxes and commissions.

### **3 – Sublicense and redistribution**

The licensee has no right to sublicense or redistribute the Work.

The licensee must ensure that its customers/users are not able to recreate and redistribute any part of the Work. Any unauthorized dissemination represents an infringement of copyright and is punishable by law.

### **4 – Activation and Duration**

This license agreement is considered activated with the download of the product by the licensee or in any case with the first act of use of the product by the licensee. From the moment of activation, all legal consequences of the license agreement take effect. This license agreement is valid from the date of activation and has no termination.

### **5 – Warranties**
